THESE CHILDREN PARTICIPATED IN A DANCE PROGRAM TO DEVELOP COGNITIVE SKILLS AND IMPROVE EMOTIONAL REGULATION. BASED ON THE MONITORING & EVALUATION SYSTEM USED TO MEASURE THE STUDENTS' LEARNING PROGRESS, WE FOUND THAT, ON AVERAGE, CHILDREN IMPROVED THEIR COGNITIVE AND NON-COGNITIVE SKILLS BY 35% OVER 7-10 WEEKS IN THE PROGRAM: WWW.MINDLEAPS.ORG/RESEARCH. WHILE PARTICIPATING IN THE PROGRAM, THESE YOUTH ALSO RECEIVE ACADEMIC ACCELERATION COURSES, DAILY MEALS, HEALTH/HYGIENE PRODUCTS, IT TRAINING, AND CLOTHING. IN ADDITION TO THE CHILDREN THAT COME TO THE MINDLEAPS CENTER IN KIGALI DAILY, THERE WERE 168 GRADUATES OF THE MINDLEAPS PROGRAM THAT WERE SPONSORED TO CONTINUE FORMAL EDUCATION. MINDLEAPS ALSO BEGAN TO DEEPEN
